



NOTICE FOR MANIFESTATION OF INTEREST BY ECONOMIC OPERATORS TO PARTICIPATE IN NEGOTIATED PROCEDURE, WITHOUT PRIOR PUBLICATION OF CALL FOR TENDERS, FOR THE CONCLUSION OF A CONTRACT CONCERNING THE SUPPLY AND LAYING OF 3 MACHINERY FOR THE CONSTRUCTION OF A FIRE BEHAVIOR STUDY LABORATORY

Given that:

- The Regional Law n. 3/2013 "Regional financial law for 2013", provides for the implementation of interventions for local economic development in the area of the Province of Rovigo aimed at strengthening the economic and productive fabric and increasing the attractiveness of the territory for investments and infrastructure development;
- 2) The Chamber of Commerce of Venice Rovigo, with a note presented to the Veneto Region on 11.2.2020, in order to access a regional contribution pursuant to art. 25, paragraph 2 bis of Regional Law no. 3/2013, presented a feasibility project called "Development of the offer of new services for innovation on a European scale in the territory: Fire Behavior Study Laboratory";
- 3) This Laboratory, to be carried out at the Cen.ser Area of Rovigo in V.le Porta Adige, n. 45, is intended, also in collaboration with universities, public and private research bodies / organizations, for research purposes also applied to verify, through the use of test furnaces, the experimental fire conditions to which to subject artifacts, structures or building portions, in order to establish their duration in terms of fire resistance;
- 4) The regional council, with resolution no. 460 of 14.4.2020, against a cost estimate drawn up by the Chamber of Commerce of Venice Rovigo of € 1,000,000.00 for the purchase of the machinery necessary for the Laboratory, authorized the granting of a maximum non-repayable grant of € 500,000.00 in favor of the Chamber of Commerce;
- 5) With determination of the Secretary General FF n. 25 of 3 March 2021, the outcome of the public tender procedure was approved, which identified T2I scarl with headquarters in Treviso, Piazza delle Istituzioni 34 / a, the subject with whom the loan agreement was stipulated concerning the instrumentation for the realization of a fire behavior study laboratory;
- 6) The main activity of the Laboratory will consist in creating, by means of test equipment, "Experimental Fire Conditions" to be subjected to artifacts, structures or building portions, in order to establish their behavior to the Propagation of Fire and the Release of Heat, Production of Smoke, Mass Loss Rate.

MAKES KNOWN

that this Administration, for the reasons in the introduction, intends to initiate a market survey in compliance with the principles of free competition, equal treatment, non-discrimination and transparency in order to identify economic operators to be invited to the procedure without prior publication of the notice for the assignment, pursuant to and by effect of art. 63,





paragraph 3 letter. a) of Legislative Decree 50/2016 and subsequent amendments, Code of Contracts, of the supply with a single lot of n. 3 machines described below for setting up the "Fire Behavior Study Laboratory".

With this notice, no awarding or competition procedure has been launched and, consequently, there are no rankings, attribution of scores or other classifications of merit. Expressions of interest have the sole purpose of communicating to the Administration the willingness to be invited to submit an offer, with a pre-selection function with respect to the subsequent phase of the procedure. This expression of interest does not bind the Chamber of Commerce of Venice Rovigo in any way, and the same reserves the right to proceed or not, at its sole discretion, to the subsequent stages of the procedure. The Chamber of Commerce of Venice Rovigo reserves the right to send an invitation to submit an offer, even in the case of receipt of only one expression of interest as long as it is valid and suitable.

1) SUBJECT OF THE CONTRACT:

This notice is aimed at collecting expressions of interest concerning the supply with a single lot of no. 3 machines listed below:

N.1 Outdoor fire exposure test machine on roofs (CEN / TS 1187)

The machine allows you to test the performance of roofs on exposure to external fire type 3: method with burning marks, wind and additional radiant heat.

The following characteristics are required:

- Radiant panel, calibration table and specimen holder frame
- Inlet air supply system consisting of blower and controller capable of applying variable air flow across the surface of the calibration element at a temperature of 20 ° C ± 10 ° C
- Anemometer to measure the air flow with an accuracy of at least 0.1 m / s
- Outlet nozzle with deflectors and flow levelers to avoid the vorticity of the flow pattern
- Radiant panel, consisting of four individual gas radiators, mounted on a plane parallel to the surface of the calibration element and at a distance of 500 ± 20 mm above it.
- Separate mass flow regulators for gas and air for each radiator so that the radiant panel is able to provide a total distribution of the heat flow on the surface of the calibration element, with wind, of 12.5 ± 0.5 kW / m2.
- Mass flow controllers, instrumentation for ignition and flame detection, solenoid valves and backfire arresters. The maximum gas flow rate (mg / s) must be digitally controlled
- Calcium silicate calibration element
- Heat flow meter
- Sample holder

N. 1 Room Corner Test - (ISO 9705)

The machine for "ROOM CORNER TEST" allows the measurement of the heat release obtained by sampling the combustion products from the combustion chamber exhaust duct and calculating the heat release rates from the mass flow rates and from the depletion of the measured oxygen in the products of combustion (according to ISO 9705). Smoke and

other combustion products can also be conveniently measured in the same process.

The machine must consist of the following components:

SENSOR AND PROBE DUCT SECTION

A section of flanged stainless steel conduit approximately in size 0.4m in diameter by 0.762m in length fitted to the flanges produced on the exhaust system. The duct will contain ports for:

- Line sampler for fume extraction (for gas analysis)
- Smoke blackout system
- Mass flow monitoring
- Thermocouple for measuring the temperature of the exhaust gases

• Thermocouple for measuring the gas temperature in the smoke measuring position

Equipment for mass flow monitoring should also be included including:

- Bidirectional probe, differential pressure transducer and thermocouple

DATA ACQUISITION AND ANALYSIS SOFTWARE

The signals must be collected using a Data Logger. A Windows-based software package should allow for simple data acquisition and analysis to determine the various parameters required for determining heat release.

The system must include:

- Data Logger with memory that must be configurable to keep data even after the power has been removed, so that the data can be uploaded to a PC at a later time.
- Software

- economic-financial capacity requirements: The competitor must have at least one bank reference issued by a banking institution certifying the financial capacity and solidity of the company, and that the same has always met its commitments with regularity and punctuality;
- 4) **professional technical ability**: The participant must have carried out at least one supply and installation similar to that covered by this announcement in the last 10 years.

5) METHODS AND CRITERIA FOR CHOOSING CANDIDATES

For the supply in a single lot, the identification of the group of economic operators who will be invited to submit their offers will be carried out by the RUP which, on the basis of the documentation contained in the applications submitted for this equipment, will proceed to verify its formal correctness and possession. the requirements of this notice for candidates.

It should be noted that the invitation to submit an offer will be sent to all operators who meet the requirements indicated in the previous article. The selected candidates will be invited simultaneously and in writing, according to the procedures indicated in the invitation letter, to submit their respective offers.

For the single supply lot, we will proceed as described above even in the presence of only one expression of interest received within the deadline set out in this notice.

The RUP reserves the right not to proceed with the award of the contract if no offer is convenient or suitable in relation to the subject of the contract.
